

Information:

HB 1079 is the abbreviation for House Bill 1079. It is a bill that was signed by former Washington State Governor, Gary Locke, in May 2004. This bill enables undocumented students to pay in-state tuition to attend Washington colleges and universities only. Before HB 1079, undocumented students were required to pay non-resident tuition which is almost three times more than resident tuition.

To be eligible for HB 1079, a student must meet the following requirements:

The student must live in Washington State for the three years immediately before receiving a high school diploma *and* must complete the full senior year at a Washington high school.

**OR...**

The student must live in Washington State for the three years immediately before receiving a General Education Development (GED®).

**AND...**

The student must have lived in Washington State continuously since earning the high school diploma or GED®.

Undocumented basic studies students who do not meet the above eligibility requirements might consider completing the GED. To enter either the ABE or GED program at SSC, students take an assessment test. Students may be enrolled in the ABE program if their assessment scores are at a 5<sup>th</sup> grade level or higher. To enter the GED program, assessment scores should be at a 9<sup>th</sup> grade level or higher. Undocumented students in advanced ESL classes often have the skills necessary to transition into ABE or GED classes.

Upon completion of the GED, students can take the COMPASS or ESL COMPASS test, see an advisor, and register for classes. When registering, students must submit the HB 1079 Affidavit (attached). To get additional copies of the affidavit, go to [www.leapwa.org](http://www.leapwa.org).

**Note:** HB 1079 does not change a student's legal status, but it makes the students eligible for state financial aid and in-state tuition.

## Washington Higher Education Residency Affidavit/Declaration/Certification

Effective July 1, 2003, Washington state law changed the definition of “resident student.” The law makes certain students, who are not permanent residents or citizens of the United States, eligible for resident student status – and eligible to pay resident tuition rates – when they attend public colleges and universities in this state. The law does not make these students eligible to receive need-based state or federal financial aid. To qualify for resident status, students must complete this affidavit/declaration/certification if they are not permanent residents or citizens of the United States but have met the following conditions:

Resided in Washington State for the three (3) years immediately prior to receiving a high school diploma, and completed the full senior year at a Washington high school,

**or**

Completed the equivalent of a high school diploma and resided in Washington State for the three (3) years immediately before receiving the equivalent of the diploma,

**and**

Continuously resided in the State since earning the high school diploma or its equivalent.

Additional Information:

Selective Service registration is required for many types of federal financial aid and benefits programs. Selective Service does not collect any information which would indicate whether or not you are undocumented. You may want to protect yourself for future U.S. citizenship and other government benefits and programs by registering with Selective Service.

“Men who have registered remain eligible for federal student aid, most federal jobs, and federal job training. Male non-citizens living in the U.S. who are 18 through 25 must register to remain eligible for citizenship.”
